# **December Community Outreach Concludes and January Community Outreach Begins**

A huge thank you to all those who purchased a gift for a child identified on the Angel Tree and/or donated hats, gloves, undergarments and other winter accessories. All toys and items were delivered to the Salvation Army to be included in their Family Christmas Shop for families in need.

Throughout the month of January, we will be collecting items for HFHS "Street Medicine" program in conjunction with Michigan State University. Street Medicine is founded upon a commitment to the ideals of social justice and the right to health care for all. Street Medicine providers aim to serve people experiencing homelessness and/or those living without health insurance by bringing empathetic health care to the streets and shelters.

Providers offer medical treatment, with follow-up, connections to health education and social services such as housing, and most importantly, the compassion, trust and respect that so many people have been denied.

Each week a student-led medical group works alongside licensed medical providers to serve those in need on the streets and shelters. In keeping with the program's philosophy of caring for the whole person, each patient is offered hygiene items, socks, hats, gloves, and warm clothing throughout the winter.

A collection box will be set up in the narthex for all those who would like to help support this program through the donation of hygiene items, hats, gloves, socks, and blankets.

A street medicine medical provider will be offering more information and insight into this program during a moment of interest in January.

#### **Open Council Positions**

#### 2024 Budget Status

Our actual income YTD is \$194,890 and our actual expenses YTD are \$195,002 a difference of (\$112) this is a decrease of about \$2,000 from last month. Our General Fund, which is the fund we use to pay our expenses (salaries, utilities, etc) is at \$23,648 a increase of about \$1,651 from last month. Please keep in mind that although the numbers don't look that alarming, you must keep in mind that we are currently not paying salaries for two major positions (Music Director and Director of Christian Education). I will continue to only talk about actual income vs actual expenses as we close out the year. I will however talk about the Budget shortfall at our Annual Meeting in January. #### Qualified Charitable Distribution - Did you know?

The Secure 2.0 Act of 2022 changed the age for Minimum Required Distributions from 72 to 73 years of age, however it had no impact on Qualified Charitable Distributions. QCD is a direct transfer of funds from your IRA custodian, payable to a qualified charity, St. Paul does qualify. QCDs can be counted toward satisfying your minimum required distributions (MRDs) for the year. Since it is already excluded from your taxable income, you can't take the itemized deduction (charitable donation) again. That would be double-dipping. While many IRAs are eligible for QCDs—there are requirements:

- You must be 70½ or older to be eligible to make a QCD.
- The maximum annual amount that can qualify for a QCD is \$100,000. This applies to the sum of QCDs made to one or more charities in a calendar year.
- For a QCD to count towards your current year's MRD, the funds must come out of your IRA, generally by December 31.
